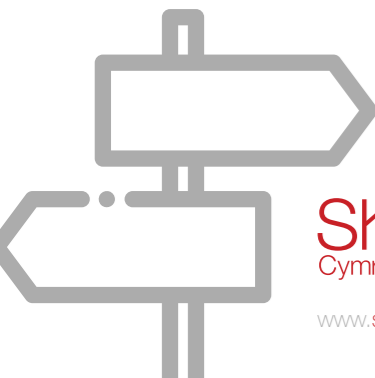


9 Signs

Have they recently had a relationship breakdown?

This could separate the household and threaten the tenancy.

Do they seem to be struggling financially?

Are they trying to save money on basics such as food or transport? This may mean they are also struggling to cover their rent or mortgage.

Have they spoken about the condition of their home?

Perhaps they can't afford repairs. This could affect their health or even make the home too dangerous to live in.

Have terms and conditions changed in their workplace?

Have they had their hours reduced or been made redundant? This could impact on their ability to pay bills.

Are they having health problems, physical or mental?

This could affect their ability to deal with everyday matters, and their home could become unsuitable for their needs.

Have they spoken of the difficulty of finding a home?

A person may be struggling to find a suitable property they can afford due to high fees, rents or set-up costs.

Are they changing jobs?

This could affect their income. If their accommodation is tied to their job they may need to find somewhere else to live urgently.

Changes such as the benefit cap could put them in hardship even if they've been managing fine so far.

If there's a new addition to the family or if someone moves out, this could affect the household income.
